Consignment Form

Section 1. Terms: By entering into this consignment contract, Consignor agrees to allow Park Avenue Numismatics Auctions (Park Avenue) act as Consignor’s selling agent for all of the items listed in section 8 (including any additional pages attached to this form), and to sell each item to the highest bidder in a Park Avenue auction. Consignor represents to Park Avenue that Consignor is the rightful owner of the items or is authorized to sell them, and Consignor will fully indemnify Park Avenue against any adverse claims. Consignor agrees that should a buyer of one of Consignor’s items not pay for the item, Park Avenue may sell the item to the under bidder at the price of the winning bid for a period of 30 days from the end of the auction, or place the item in another Park Avenue auction. Upon execution of this contract, Consignor may not withdraw any item from the auction, but Park Avenue reserves the right to withdraw items from the auction if: (1) There are questions and or concerns as to the authenticity of the item; (2) the item has been misrepresented; (3) Consignor breaches any section of this contract. If Park Avenue Numismatics Auctions has to refund money to a buyer for any reason after the seller has already been paid, Consignor must reimburse Park Avenue for the refunded amount. If there is a question of ownership, Park Avenue Numismatics Auctions reserves the right to identify Consignor. Short of this unusual circumstance, all Consignor information shall remain confidential.

Section 2. Authenticity: Consignor guarantees the authenticity of each consigned item without time limit. Park Avenue Numismatics Auctions will obtain third party authentication when necessary and pass through our negotiated auction fee of \$15 per lot to the seller.

Section 3. Payment: Consignor will be paid thirty (30) days from the closing date of the auction. To encourage auction participation, Consignor will be allowed to use money owed as payment toward any lots won in the auction provided that Park Avenue has been paid for the items consigned by Consignor.

Section 4. Fees Park Avenue Numismatics Auctions will retain a buyer’s fee of 12.5% on all of the lots sold in the auction.

Section 5. Minimum Bids: Each item listed in section 7 will have an acceptable minimum bid that will be determined by Park Avenue in its sole discretion.

Section 6. Unsold/Rejected Items: After inspection by a third party authenticator, Park Avenue will return any rejected products within 30 days. Any items that do not receive an opening bid may be auctioned again in the next Park Avenue sale or will be returned within thirty (30) days of the closing date of the auction.

Section 7. Dispute Resolution. Any dispute arising out of this consignment shall be resolved by binding arbitration through the American Numismatic Association according to ANA rules and procedures or, if ANA does not agree, to the American Arbitration Association under AAA’s Commercial Arbitration Rules, with venue in Miami, FL
